The Afton City Council met in special session at 5:50 PM, Thursday July 17, 2008. Mayor Michelle Burger presided with Council members Jeff Burger, Sherry Parrott, Ann Tunnicliff, and Dave Cunningham present. Cindy Williams was absent.

Parrott moved to approve the agenda and Tunnicliff seconded the motion. Roll call votes of all ayes. Motion Carried.

The Council scheduled six interviews with prospective Maintenance/Sewer Employee candidates. At 5:52 PM candidate #6 requested to go into closed session pursuant to Iowa Code 21.5(i) – to evaluate the professional competency of an individual whose appointment, hiring, performance or discharge is being considered when necessary to prevent needless and irreparable injury to that individual's reputation and that individual requests a closed session. Parrott moved to grant this request for closed session and Tunnicliff seconded the motion. Roll call votes of ayes: Parrott, Burger, Cunningham, and Tunnicliff. Motion carried. Closed session ended at 7:10 PM.

At 7:12 PM candidate #9 requested to go into closed session pursuant to Iowa Code 21.5(i) for interview purposes. Burger moved to grant this request for closed session and Cunningham seconded the motion. Roll call votes of ayes: Cunningham, Parrott, Tunnicliff, and Burger. Motion carried. Closed session ended at 7:23 PM.

Cunningham moved to grant this request for closed session and Burger seconded the motion. Roll call votes of ayes: Burger, Tunnicliff, Parrott, and Cunningham. Motion carried. Closed session ended at 7:38 PM.

Burger moved to grant this request for closed session and Cunningham seconded the motion. Roll call votes of ayes: Parrott, Burger, Tunnicliff, and Cunningham. Motion carried. Closed session ended at 8:04 PM.

Parrott moved to adjourn and Tunnicliff seconded the motion. Roll call votes of all ayes. Council adjourned at 8:19 PM.
