Hill moved to approve Ordinance No. 222. Burger seconded the motion. Roll call votes of ayes: Williams, Burger, Hill, Cunningham and Parrott. Motion carried.

OLD BUSINESS:

The City Clerk gave an update on the Electric Projects. Casey's has approved donating their parcel of unused land north of their store to the City for the substation project. Once the land is

transferred we can do soil boring. JEO Consulting Group updated via written correspondence that they will have something put together and can go out for bids in either March or April but finalization of the land transfer will dictate when the project is put out to bid. JEO will be requesting approval to put out the substation transformer bid package in March.

Police Chief Coulter handed out an updated nuisance list of 8 properties. Council reviewed and discussed and noted 200 W. Railroad needs added to the list.

Council discussed color and pattern options for the new splashpad that is to be completed this coming Memorial Day weekend. Council agreed on a light blue color for the splashpad area with Waterpark (dark) Blue color stars on the pad and in the border. Parrott will do a computerized drawing with these colors and design and get it to the City Clerk who will forward to the contractor.

Rex Allen from the DOT notified the City Clerk on the results of the sight study completed in November of 2013 for a crosswalk on Hwy 169 from the alley by the Community Center to the park. Allen recommended limiting parking to passenger cars or no parking directly adjacent to the proposed crosswalk and noted there should be a hard surface area or sidewalk at the connection point with the park to accommodate ADA pedestrians. The DOT will provide signing at the crosswalk if the City paints and maintain the crosswalk. Council directed the City Clerk to get quotes on the curb cut and hard surface entrance to the park.

Hill reported the Wellmark 2015 Small Grant Program application process is going well and Jeremy Rounds with SICOG is getting close to being ready to submit. She received several letters of support for the project and there has been interest to contribute money and labor from several homeowners on the route.

City Clerk reported that Veenstra & Kimm is working on the sewer lining and has given a timeline of receiving quotes for the March meeting with completion of the project by 7/31/15.

NEW BUSINESS:

An update was given to the City Clerk and Maintenance/Street Supervisor by Iowa DOT – Atlantic office. Highway 169 from Filmore Street south to the City limit will be let out for bid in March 2016 and reconstruction of this area will be completed during the construction months of 2016. The DOT will cover all costs of this project. The Iowa DOT will also be doing a bid letting in December of 2015 for a 2016 ADA sidewalk project from Filmore north to Union. Sidewalks and corners will be fixed to met ADA requirement along this stretch of Hwy 169.

Insurance Agent Proposals were opened and reviewed. Council reviewed proposal from Hometown Insurance with agents Jamie Travis & Allan Landers teaming up with Jim Lane with Jester Insurance on our EMC Policy and Allan assigned as the local agent. Burger moved to approve the proposal received from Hometown Insurance. Williams seconded the motion. Roll call votes of ayes: Cunningham, Hill, Parrott, Williams and Burger. Motion carried.

Council discussed Ordinance Chapter 142 – Trees. Parrott felt that no trees should be planted in the City right-of-way/parking area due to the expense it causes the City if they need removed.

Council discussed in more detail and an ordinance change will be presented at the March meeting with planting restrictions changed to not allow in City parking or streets.

Williams moved to review Chapter 140 – Abandoned Vehicles at the March meeting. Hill seconded the motion. All voting in favor and the motion carried.

Parrott moved to adjourn and Burger seconded the motion. Roll call votes of all ayes. Council adjourned at 7:34 PM.
