Williams moved to approve Resolution 2018-02 RESOLUTION TO DETERMINE DATE OF PAYMENT FOR THE COUNCIL OF THE CITY OF AFTON, IA. Cunningham seconded the motion. Roll call votes of ayes: Hill, Burger, Williams, Cunningham & Parrott. Motion carried.

Williams moved to approve Resolution 2018-05 RESOLUTION PROVIDING FOR SURETY BOND/BLANKET POSITION BOND. Cunningham seconded the motion. Roll call votes of ayes: Williams, Hill, Cunningham, Parrott and Burger. Motion carried.

Parrott moved to approve Resolution 2018-06 RESOLUTION ESTABLISHING CITY ATTORNEY FEES. Burger seconded the motion. Roll call votes of ayes: Cunningham, Burger, Parrott and Hill. Nay vote: Williams. Motion carried. New City attorney will be Meggen Weeks at \$180/hr and Matthew C. Hanson at \$200/hr with the Wilson, Hanson & Associates P.C. law firm.

Parrott moved to designate the Afton Star Enterprise as the official paper for publications and Cunningham seconded the motion. Roll call votes of ayes: Williams, Burger, Parrott and Cunningham. Abstain Vote: Hill. Motion carried.

Williams moved to designate the day before Christmas (December 24, 2018) as a holiday and Burger seconded the motion. Roll call votes of ayes: Parrott, Hill, Burger, Cunningham and Williams. Motion carried.

Hill moved to approve Resolution 2018-07 RESOLUTION DIRECTING THE CLERK TO PUBLISH NOTICE OF HEARING ON THE ADOPTION OF THE PROPOSED "CODE OF ORDINANCES OF THE CITY OF AFTON, IOWA". Burger seconded the motion. Roll call votes of ayes: Cunningham, Parrott, Williams, Burger and Hill. Motion carried. The public hearing is set for February 13, 2018 at 6:30 PM.

OLD BUSINESS:

Police Chief Coulter distributed his nuisance report listing 4 residents. 205 W. Kansas and 309 N. Douglas were added by Council. Council also discussed sidewalk snow removal and snow mobiles riding around town with Coulter.

Police Chief Coulter turned in his Notice of Retirement letter with tentative retirement as of 6/30/18. Parrott asked what tentative meant and he said he would stay as long as it took to find a replacement. Police committee set up a meeting on January 18, 2018 at 3:00 PM to go over what requirements will be needed in order to run ads in the paper and on social media.

Burger moved to adjourn and Parrott seconded the motion. All voted aye. Council adjourned at 7:33 PM.
