**PUBLIC FORUM:** Sherry Parrott spoke about the students building the UCDA house on W. Filmore and feel they should be allowed to park on Filmore during construction. Wayne Hill commented when vehicles parked on Filmore they took up 1/3 of the street and he meet a vehicle that didn't stop even though he was over half way through and there was barely enough room for

both to meet. Dave Cunningham wondered about rocking the city lot for parking. Parking will be placed on the November agenda for discussion.

## **ORDINANCE/RESOLUTION:**

Williams moved to place Ordinance #237 AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF AFTON, IOWA, 2018, BY ADDING A NEW SUBSECTION THAT EXCLUDES EXPLODING AERIAL SHELL KITS AND RELOADABLE TUBES WITHIN THE CITY LIMITS OF AFTON on its 2<sup>nd</sup> reading. Burger seconded the motion. Roll call votes of ayes: Cunningham, Parrott, Hill, Williams and Burger. Motion carried.

Clerk Landers informed the Council she has discussed City accepting a donation from Richard Tyler to Greenlawn Cemetery in the form of stocks with our auditor and it is allowed. Landers is working with Raymond James Financial Services to set up an account for the donated stock. Williams moved to approve Resolution 2018-19 A RESOLUTION ESTABLISHING THE TYLER CEMETERY FUND. Parrott seconded the motion. Roll call votes of ayes: Hill, Burger, Williams, Parrott and Cunningham. Motion carried.

## **OLD BUSINESS:**

Council reviewed updated nuisance list. A total of 8 properties were listed with 4 abated, 3 in progress and 1 not abated. Officer McGuire has started working on the nuisances.

Council discussed small building at 290 N. Douglas. If building is donated to City by VFW Post 1797, Hill would like to try to make it into a computer center/Wi-Fi area. Hill had a sign-up sheet full of names of people willing to help fix up the building. Cunningham motioned to move forward with the plans discussed for this building and Williams seconded the motion. All voted in favor and the motion carried.

Clerk Landers updated the Council that the community center door problems have been sent in to the manufacture and JELD-WEN has assigned a claim number. We should hear back from them soon and hopefully they will have a rep come look at our doors.

## **NEW BUSINESS:**

Parrott moved to advertise for part-time/on-call snow removal help with pay of \$15.00/hour. Cunningham seconded the motion. All voted in favor and the motion carried.

Council reviewed 5 asbestos removal proposals for the church at 201 W. Kansas the city acquired the deed to on 9/11/18. Hill moved to approve the asbestos removal proposal from ICM Insulation Ltd for \$8,150. Williams seconded the motion. All voted in favor and the motion carried.

Council reviewed 8 bids for demolition and removal of the church at 201 W. Kansas. Clerk Landers had discussed church building with DNR and we can do a demolition burn as an option. The bricks, mortar and concrete or similar rubble can be salvaged. Williams moved to approve H&H Commercial Services bid of \$24,500 that includes removal of all debris with no burn. Parrott seconded the motion. Roll call votes of ayes: Cunningham, Hill, Parrott, Williams and Burger. The motion carried.

Healthcare renewal workshop on 10/16 in Ankeny has been cancelled. Clerk Landers said the renewal package will be sent once Wellmark BC/BS has them ready and our agent with Mark J Becker & Associates will contact us and go over current plan and other options at that time.

Brown Power & Control has informed the City they will no longer be able to continue doing the electrical contract work and would like to be done by the end of this year. Council discussed and asked the Clerk to get together with Keith Brown to go over the specification we will need from another contractor and start looking at our options.

IEDA is offering the Community Catalyst Grant with pre-application due 11/14/18. Council discussed several building around Afton that might be a good fit for this grant. Hill moved to see if Jere Busenbarrick is interested with his buildings at 155-175 E. Kansas. Cunningham seconded the motion. All voted in favor and the motion carried.

Cunningham moved to appoint Rob Dike to the Recreation board. Parrott seconded the motion. All voted in favor and the motion carried.

Parrott moved to adjourn and Burger seconded the motion. All voted aye. Council adjourned at 7:49 PM.
