**PUBLIC HEARING:** At 6:31 PM Mayor Burger announced it was time for the public hearing on the proposed use of real estate at 201 W. Kansas by the Afton Fire Protective Association. Hill had concerns on if a variance would be needed. Allan Landers was present for the fire department and said their next step would be to see if they could make a building work on this size corner lot. Council will wait to hear back from the fire department on the lot. The public hearing was closed at 6:34 PM.

## **RESOLUTION:**

Hill moved to approve Resolution 2019-09 A RESOLUTION ESTABLISHING CHANGE OF MUNICIPAL HOUSING COMMISSION TERM DATES. Williams seconded the motion. Roll call votes of ayes: Cunningham, Parrott, Hill and Williams. Motion carried.

**PUBLIC FORUM:** No one present spoke.

## **OLD BUSINESS:**

Council reviewed the nuisance report listing 5 properties. 708 E. Grand was discussed. Cunningham moved to have Police Officer McGuire talk to owners and if property is not cleaned up by May 1<sup>st</sup> turn it over to our attorney and start the court process. Williams seconded the motion. All voted in favor and the motion carried.

Hill gave an update on the Wi-Fi project. A silent auction was held March 23<sup>rd</sup> and we received \$166 for some of the items inside. Hill is waiting to hear back from a couple people on the medical items, but if they are not interested we will put them on the GovDeals.com auction site. Clerk Landers said we have not received information back yet on our grant application.

Chad Rieck from the Union County Fair Association was present to discuss their 14 day beer license application. A sketch provided showed the beer garden area and fenced in arena area where beer will be allowed. They will designate the south covered seating area as a "Family Zone" that will be alcohol free. He also provided staffing/security information in the works.

Cunningham moved to approve the beer license and Parrott seconded the motion. Aye votes: Cunningham, Parrott and Williams. Nay vote: Hill. Motion carried.

Council reviewed asphalt and concrete bids for this summer's street project. Parrott moved to approve the Henningsen asphalt bid of \$117.00/ton for 5 streets, exclude the 2 dead-end less traveled streets, and the Feldhacker concrete bid of \$43,698 for 2 sections of East Filmore. Cunningham seconded the motion. All voted in favor and the motion carried.

## **NEW BUSINESS:**

Nate Purdy and Blake Wuebker, next year's East Union junior class students, requested permission to leave the can trailer at its present location for their 2020 prom fundraiser. Hill moved to approve the can trailer request and Cunningham seconded the motion. All voted in favor and the motion carried.

Devon Springer discussed plans to start a sand volleyball league and a slow pitch league this summer. Springer would like permission to allow carry-on beer at the Rec Complex during the adult leagues. Chapter 23.04 (11) does not allow alcohol at the Recreation Complex. Springer will meet with the Recreation Board to discuss the youth schedules and work with them to come up with guidelines for allowing carry-on beer at the complex and report back to City.

Council reviewed a request from Darren & Michelle Moore to close 1 block of E. Scott Street from S. Gregory going east to the alley past Afton Housing on Saturday, June 8 from Noon to 9:00 PM for a block party. Hill moved to approve the street closing request and Cunningham seconded the motion. All voted in favor and the motion carried.

Cunningham moved to reappoint Dale Manship to the Afton Housing Commission for a five year term to expire 4/1/24. Parrott seconded the motion. All voted in favor and the motion carried.

Hill moved to approve McNeill Tree Service quote of \$3,500 to trim branches around the primary, secondary and service lines in Map 1 of the Tree and Vegetation Plan and \$1,000 to trim branches from primary lines throughout to rest of Afton. Cunningham seconded the motion. All voted in favor and the motion carried.

Council discussed Millie Skarda's request to change the Gary Skarda memorial funds being held for additional walking trail to the Afton Volunteer Fire Department if possible. Cunningham moved to approve cutting a check to give the memorial donations to the Afton Fire Dept per the family's request. Williams seconded the motion. All voted in favor and the motion carried.

Cunningham moved to adjourn and Hill seconded the motion. All voted aye. Council adjourned at 7:30 PM.
