Public Forum: Ernie Abell asked for clarification of what is considered a business in the city of Afton. This stems from a commercial property on E Kansas St. that is for sale. Some potential buyers are concerned about what businesses are allowed to be at that location. Some feel the ordinances regarding businesses on the square are somewhat vague or confusing. The main question is, can an Airbnb go in the building or does it need to be a specific type of business. The City will look into it and get back to Ernie Abell.

Resolution/Ordinances:

Old Business:

Police Chief McGuire went to court on Feb 25th for the nuisance property at 400 E Kansas. The property owner appeared in court. The judge granted the property owner an extension until April 2025. If the property is not cleaned up to standard by the court ordered date, then the city automatically wins the case. At that time the city can clean up the property and bill the property owner for the expenses.

NEW BUSINESS:

Michael Bockoven & Sara Carpenter submitted a livestock application for chickens and paid the annual livestock fee. Nixon made a motion to approve the livestock application. Parham seconded the motion. All Aye. Motion carried.

City Employee Jesse Shade went over the list of streets that need repairs. The City received a bid from Feldhacker Contracting, LLC. The locations for the concrete bids are parts of E. Filmore, intersection of E Filmore and Webster, East of the New Coop. the total estimate for the 3 projects is \$55,433. the council discussed the projects. Cunningham made a motion to approve Feldhacker' s bid for the concrete projects for FY 2026.burger seconded the motion. All voted aye. Motion carried.

Doug and Georgia Pettit were previously selected as grant applicants for the exterior beautification grant. Pettit's provided pictures, copies of bills, and payments for the project. Nixon made a motion to approve the grant payment to Pettit's for \$500. Burger seconded the motion. All vote aye. Motion carried.

City Clerk requested approval to attend training June 9-12, 2025 located in Ames, Iowa and travel expenses. Kinyon made a motion to approve training and travel expense. Burger seconded the motion. All voted aye. Motion carried.

Utility clerk requested approval to attend Conference April 21-22, 2025 located in Akeny, Iowa and travel expenses. Kinyon made a motion to approve conference and travel expenses. Cunningham seconded the motion. All voted aye. Motion carried.

Council person Nixon requested that the mayor sign a proclamation for Week of the Young Child April 5-11th 2025. Mayor Burger complied and signed the proclamation declaring Week of the Young Child in Afton, Iowa, April 5-11, 2025.

Due to recent weather events and power outages on the East side of the City of Afton on March 5th, the council discussed shelter protocol and possible ways to improve the City's preparedness for long periods of power outages. Nixon made a motion to set up a sub committee to meet with East Union Schools regarding shelter/warming centers in the community. Kinyon seconded the motion. All voted aye. Motion carried. Nixon and Kinyon volunteered to be on the committee and meet with East Union Schools.

During the power outage on March 5th city employees opened the community center for a warming center for those without power. It was discussed that the city should have some supplies specifically for power outages due to weather events.

The council discussed shade in the park near the splash pad in FY 26. It was discussed that shade cloth/fabric would be best. It was discussed that the city applies for a grant to purchase/install the shade. Kinyon made a motion to install a shade in the park near the splash pad. Burger seconded the motion. Motion carried. The city clerk will complete the grant paperwork.

The council was presented with a copy of the Notice for the Proposed Tax Levy for FY 2026. The notice will be posted in the paper March 13, 2025.

The Council was provided with a list of upcoming meetings and hearings for March 2025. March 25, 2025 at 6:30pm there will be a public hearing for the Proposed Tax Levy for FY 2026, at city hall. March 25, 2025 there will be a special meeting at 6:45pm at city hall to set the public hearing for the Proposed Budget for FY 26. The city received one bid for the trimming of trees around power lines. The bid was for \$4200. Cunningham made a motion to approve the bid for \$4,200 from David McNeil. Burger seconded the motion. All voted aye. Motion carried.
